Dear Worth 127 Families,

Thank you for your continued patience and understanding as we journey through this pandemic together. All students will continue remote learning through the end of the day on **Friday, February 5**. The tentative date to return to in-person hybrid learning was January 21. Still, because we are revising the in-person model to offer more time in in-person learning, preparation time is needed. Worth 127 will start offering in-person learning on **Monday**, **February 8**, for parents choosing this option. If you prefer in-person learning for your child, please read the following **important points regarding in-person learning**.

- Students and staff will social distance as much as possible, understanding that every
  classroom configuration, capacity, and class size will vary. Because of these variables,
  we are unable to provide a set number of feet between each student. All non-essential
  furniture has been removed from classrooms to allow for more room for each child's
  work area.
- Students will remain at the same desk in the same classroom except for individually needed circumstances. All desks will be in rows with all students facing the same direction.
- All students and staff must wear masks.
- All students and staff must self-certify every school day to assure they do not have COVID-19 like symptoms or have been in close contact with someone with COVID-19.
- In-person learning will be in the morning five days per week for four hours, with an additional hour of remote learning in the afternoon.

- Lunch will not be served in school.

If you choose **remote learning** for your child, remote learning will be **livestream** during in-person class times.
