1. MEETING OPENING

A. CALL TO ORDER

President Drew Sernus called the meeting to order at 6:12 p.m.

2. SUPERINTENDENT'S REPORT

A. WORTHWOODS/WORTH JUNIOR HIGH CONSTRUCTION UPDATE

Dr. Fleming opened his report by stating that the construction at Worthwoods is going well and at the west end, concrete has been laid. The north addition has much more utility work to be done and we are working with Comcast regarding next steps. Work at the junior high is progressing very well and you will see brick being laid at 112th.

B. METROPOLITAN WATER RECLAMATION DISTRICT (MWRD)

Dr. Fleming stated that the district still has not received the appraisal from MWRD. He has reached out to them by email several times and has not received a responds. At this point, it looks like we will have to find a way for DLA Architects to work on this and find a way to pump water out of the underground source. Dr. Fleming stated he will continue to pursue communications and follow up with MWRD.

Update from Principal, Jason Tooth (not on the agenda)

Mr. Tooth stated he wanted to recognize the junior high volleyball team that just concluded their season. The boys coach was Ms. Shannon Garbie; and Ms. Leah Schissler was the girls coach. They did a great job this season working with our students and helping them be a prat of our school culture and understanding how that works. Girls took 5th place overall in their conference and participated in the playoffs; the boys took 2nd place overall in their conference. The All-Star game took place Tuesday evening and we had four students participate: two boys and two girls. Mr. Tooth stated it was a really great season and we are really proud of their accomplishments. Mr. Tooth further stated that cheerleading along with basketball trials will be taking place.

Mr. Tooth stated that our Library Media Specialist, Natalie Valenti, applied for a grant through Dollar Tree and the district was award a \$3,000 grant that goes to districts that could use help in supporting multilingual learners. She has been working with our ML department so we can grow our library in their native language.

National Walk and Roll to School Day took place today which is organized by the National Center for Safe Routes to School. The event promotes walking to school and emphasizes safety, with students riding bikes, scooters, or walking. The tradition started at Worthwoods and we are glad to bring it back this year to encourage physical activity. There is much research that shows it really helps with learning. The event included meeting spots, staff walking with students, and receiving stickers and balloons, highlighting the importance of safe routes to school.

C. FISHING CLUB UPDATE

Sergeant Mike Cozzi gave an update regarding the Fishing Club's fourth season, which has become a significant community event. The club teaches students valuable life skills like patience, teamwork, and environmental stewardship and families have become very involved. The number of participants has grown from 15 to 25 to now approximately 40 kids. Officer Cozzi stated that we have a neighboring business in Tinley Park, Angers Outlet, and they have generously offered to cover all costs. Dr. Fleming, Mr. Tooth, and Mrs. Wills have often participated and Mayor Werner and her husband consistently attend.

Dr. Fleming and Board Members extended their sincere appreciation for the fishing club and how it has impacted students' lives.
